Out of respect for all Illinois Clubs, the committee decided that (as we have done before) production companies will need to be connected to an Illinois Member Club to be put on the Illinois State Calendar. There will be no exceptions to this policy.

A motion was made where Production Companies requesting a meet in Illinois must be associated with an Illinois Member Club or they will not be allowed on the Illinois Meet Calendar.
