NEW VAULT EQUIPMENT

Norbert Bendixen received a call asking how Illinois was going to address the new "springier" vault table that may be used this season in various invitational meets. He reached out to 2 states (that the caller mentioned, as to who might have addressed this and how they were handling). He received an answer from one. The committee discussed if this would be required at IL State meets, but tabled the discussion until Norbert gathers additional information. Norbert heard clarifying statements made at the State Chairs Workshop that this table top will NOT be used at Dev. Nationals &/ or Easterns. He's awaiting the Regional committee to address if it will be used at Regionals.

OUT OF STATE SCORES

A motion was made to <u>rescind</u> the committee's motion June 11, 2025 that read: A motion was made that all Illinois gymnasts must earn their qualifying score at an in-state meet except for Levels 8, 9 and 10.

The committee <u>will allow</u> out of state qualifying scores for the 2025/2026 season. The committee will evaluate how the new reporting system (Google form) & strict entry deadline improves score verification for Level Chairs.
