JUDGES EDUCATIONAL OPPORTUNITY

The committee discussed potential judges to offer the state meet educational opportunity to. 2026 Regional Leotard Purchase

Jessica reported that we ordered 2,186 regional leotards, which is approximately 500 more than last year. This is our first year using this process and are fielding suggestions to improve next year. We plan on sending the email regarding the regional leotards out earlier next year and provide clear instruction to the clubs on the ordering process and firm deadlines.

A motion was made FOR THIS YEAR ONLY, because it is a new process, to place a second order. The GK price of the leotards will be determined by the number of leotards ordered. If the number is below 100 leotards, the price per leotard will be \$70. Price per leotard decreases as the number ordered increases. Clubs will need to fill out a Google form by January 25, 2026. After the committee calculates the total number of leotards ordered, Jessica Holtz will email those clubs a link to pay for them by January 27th, 2026.
